Subject: Northern Development Initiative Trust 2020 Nominal Funding

Allocation

Recommendations:

THAT the staff report entitled "Northern Development Initiative Trust 2020 Nominal Funding Allocation" be received for information.

BACKGROUND:

Annually the North Coast Regional District (NCRD) is permitted to expend 7% of its nominal funding allocation on projects that support economic development in the rural areas of the NCRD. Projects seeking funding in the region are required to obtain a letter of support from the NCRD Board prior to being considered for approval from the Northern Development Initiative Trust (NDIT) Northwest Regional Advisory Committee.

In 2016, the Electoral Area Advisory Committee (EAAC) amended its terms of reference to establish an allocation model and decision making process for the issuance of funding through the NCRD nominal account which sets the following procedure:

- Each electoral area is entitled to a maximum dollar amount from the nominal allocation that is reflective of each electoral area's annual participation in the economic development service;
- Where applicable, projects are to be evaluated based on alignment with the NCRD Board priorities; and
- In the event that the allocation assigned to an electoral area will be unused, the EAAC may, upon the recommendation of the electoral area Director, reassign the allocation funding from one electoral area to one or more electoral areas.

DISCUSSION:

NDIT has advised that based on the December 31, 2019 NCRD nominal account balance the 7% annual granting maximum for 2020 is equal to \$97,268. In 2019 the grant maximum was \$89,094. The following table outlines the 2020 grant maximum per area in consideration of each electoral area's participation in the NCRD economic development function:

At the December 13th, 2019 Board meeting the NCRD resolved to support an application to NDIT for a grant of up to \$35,000 to host a Local Government Management Intern under the internship program with funds to be allocated from the NCRD Nominal Funding Account. Confirmation of this grant program funding will occur in early 2020. In consideration of this application, the remaining funding in the nominal account is calculated to be \$62,268. The resulting 2020 grant maximum per area after consideration of the internship application would be:

SUMMARY AND CONCLUSION:

In 2020, the NCRD NDIT nominal account maximums were increased from \$89,094 in 2019 to \$97,268. Staff continuously tracks projects approved throughout the year to report to the Board and EAAC on remaining allocations of NDIT grant funds as applications are considered. Representatives from NDIT are scheduled to attend the May 22nd, 2020 meeting as a delegation to discuss the nominal account funding.
